No.ZA-72/C&I/2016-17: Applications are invited from individuals and institutional applicants under Prime Minister's Employment Generation Programme (PMEGP) for the year 2017-18 through the **online portal** as per guidelines of Ministry of MSME. Online application will be from 9th November, 2017 to 21st November, 2017 at <http://www.kviconline.gov.in/pmegp>. Application under PMEGP **online** should be submitted to the respective District Industries Centre, Khadi & Village Industries Commission, Imphal and Manipur Khadi & Village Industries Board (MKVIB). Applicants should be domicile of the District where applications under PMEGP are uploaded online and they should submit the hard copies of the application with relevant documents to the respective General Managers, DIC during office hours. However, applicants residing in urban areas are to submit **online** only to the respective DICs. Applicants while submitting their applications should attach the Detailed Project Report (DPR) under DPRPACKAGE in excel with Datasheet.

Applicants may please note that User ID and Password at the time of initial registration (application filing) will be provided for e-tracking the status of their applications. Each applicant will be provided with application ID on final submission. There will be provision to upload the Aadhaar, PAN card, Photo and documents comprising (a) Caste/Tribe certificate, (b) Special category certificate, wherever required, (c) Rural area certificate, (d) Project report, (e) Educational qualification/ EDP/ Skill Development training certificate, (f) In case of Institutions, self-attested copies of the following documents are also required (i) Registration certificate, (ii) Authorization letter/ copy of bye-laws authorizing Secretary etc. to apply and (iii) Certificate for special category. The last date for filing the application on-line will be **21st November, 2017**. Applications submitted before 9th November, 2017 and after 21st November, 2017 will not be accepted under any circumstances. The applicants are advised to contact the respective General Manager (GM) of DICs, Deputy Director, KVIC, Imphal and Chief Executive Officer/ MKVIB, Lamphel for submission of applications under PMEGP Scheme. Submission of hard copies of application and documents is mandatory for screening by the District Level Task Force Committee (DLTFC) headed by the respective Deputy Commissioners failing which the applications will be liable for rejection.
